Congregational Meeting Minutes

Minutes from January 23, 2022 Annual Congregational Meeting

Vice President Royce Anderson called the meeting to order at 9:41am. A quorum was present.

Moved, seconded, passed to approve the January 24, 2021, annual congregational meeting minutes with one correction (change January 24, 2020, to January 24, 2021, in first paragraph).

Pr. Phil Ruud highlighted his written report, reflecting on the challenges presented by the COVID pandemic and the need to revitalize our committees. He recognized and thanked the many people he has worked with during his tenure at First English.

Children, Families, and Youth Director Kris Kincaid highlighted her written report, noting that she is in her seventh year at First English. The group continues to experiment with creative ways to connect, grow, and learn.

Social Ministries and Women of First English submitted written reports.

Treasurer Karen Anderson presented the 2021 financial reports for the Church (including detailed Rooted in Faith report), Youth, Women of First English, and Foundation (including a history of the Foundation and its finances). The general fund ended the year with a balance of \$12,005.17. All accounts were audited on January 15, 2022, by Sherry Miller, Cathy Rehm, and LaNor McDonald. Moved, seconded, passed to approve all financial reports and audit.

Vice President Royce Anderson thanked retiring members of the Church Council: Royce Anderson, Bonnie Cumiford, Jane Peterson, and Rondi Sjoblom. The ballot was presented. There were no additional nominations from the floor.

Treasurer Karen Anderson presented the proposed 2022 budget. The proposed General Fund budget is \$288,251 and Building Expense budget is \$27,850. The Administrative Assistant/Financial Secretary position reflects an increase in salary with a decrease in hours worked. The low actual cost of gas in 2021 is due to having a large credit with the gas company. Of the 265 pledge cards sent out, about 100 have been returned. Moved, seconded, passed to approve the 2022 budgets as presented.

Pr. Ruud offered the closing prayer. Moved, seconded, passed to adjourn at 10:49 am.

Minutes from December 4, 2022 Special Congregational Meeting: Consideration of Calling a New Pastor

The meeting was called to order by President Mike Miller. Kay Sabin led in a devotional and opening prayer.

Attendance was taken by having attendees sign in on forms that were collected by the ushers. It was confirmed that we had a quorum.

The Call Committee was introduced. Members included Phil Jacobson (Chair), Jeff Tipton, Abby Meyers, Jayme Miller, John Peterson, and Kay Sabin.

The Call Committee presented a recommendation that First English Lutheran Church extend a call to Pastor Luke Hollander to serve as our new Pastor. They shared background information on the candidate, the proposed compensation package, and a tentative start date.

Questions were received from the congregation and answers provided by the Call Committee.

Ballots were distributed, a vote was taken and tallied: Yes = 99; No = 5

The candidate will be notified by the Council President and the Chair of the Call Committee following the meeting. The candidate will be allowed 30 days to consider the call.

The Call Committee and Transition Team were thanked for their efforts.

The meeting was adjourned with a thank you to everyone for being present and participating.

Pastor's Report

Dear People of First English,

What a "unique" year 2022 was in the continuing story of this congregation!

It's never easy to suddenly adapt to the departure of a beloved pastor—especially if that pastor had faithfully served the church since the days of President George H.W. Bush! But adapt you did! Pastor Phil Ruud retired and I arrived in mid-March to serve as the interim pastor, and literally from day one was treated like I had been part of the family for a long time. And, together, we've navigated the waters of transition and were able to secure some wonderful accomplishments along the way.

- A Transition Team was organized in late May and tasked with helping to determine the needs of First English both today and in the upcoming future. The team solicited regular input from Sunday worship attendees (who will ever forget the five minutes carved out of each summer service to answer some specific questions regarding the needs and wishes of the congregation?). A comprehensive self-study survey was conducted, which provided helpful key information to consider regarding the skills necessary in a new pastor to help us continue our mission. When all of the findings had been accumulated, the team produced a document called the 'Ministry Site Profile' to be given to any pastors interested in serving our church.
- A Call Committee was formed in the late summer to take the learnings provided by the Transition Team and use them to actually interview pastoral candidates and issue a call. Diligently, this committee poured over the Ministry Site Profile and carefully discerned the candidate who best matched the needs of First English. Upon an approval vote from the congregation, a call was issued to Pastor Luke Hollander who is set to begin on Jan. 16th.

- All the while that the Transition Team and Call Committee were working, the "regular" ministry of the congregation continued unabated. Confirmation classes...Wednesday Lenten worship services... Sunday School and VBS...WELCA meetings...Food Shelf hours...youth events...normal Sunday worship...funerals...weddings...etc....all continued to happen as before. Basically, together, we kept moving forward—trusting that God would be with us to guide us as always.
- And, just to add to the shifting sands, in August we bid a fond farewell to longtime youth director Kris Kincaid as she began her pastoral internship year. Without missing a beat, an interview team came together and brought Maddie Patterson in to serve as our new Children, Youth and Family director. Maddie's energy and skills have been a great asset to First English.

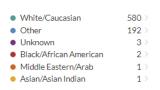

Thanks to Kathy's flexibility and supreme organizational skills, any turmoil associated with all of the "moving parts" of 2022 was dramatically minimized. 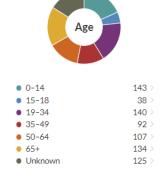

Children, Youth and Family Ministry **2022 Year-End Report**

As the school year started up, the youth jumped into confirmation. Each Wednesday night they gather to eat, learn, and worship Jesus. Additionally, confirmands meet with their mentors once a month for lessons on how to be a better neighbor. All of this is done to help the youth learn and understand the Christian faith.

Although they have been working hard, FELC youth have also had time for fun. This fall we hosted the Fifth Quarter fun night with St. Ansgar's, where youth gathered for a bonfire, games, and devotional. We will be having more events like this in the future, so keep your ears open for more information!

Family Ministry

For family ministry Kickoff Sunday started the year. As we gathered to celebrate Rally Sunday, we partied with outside games and food for all. This event also helped bring in volunteers for the upcoming year. It was a great way to start off Sunday School and Confirmation.

In family ministries, connections and learning have taken place through the milestones program. Each age group has met for their milestone where they received a gift and short lesson.

Worship and Music **Annual** Report

Highlights of 2022:

- Organ repair Old speakers which were disintegrating and creating 'buzzing' sounds when the organ was played were replaced. A new backup battery was also installed.
- Make a Joyful Noise hymn and worship song request project During the summer months people were invited to submit requests for worship music via a drop box by the sanctuary door. Almost 30 requests were received and the hymns and songs were included in summer worship services.
- Music groups resumed The Adult Choir, Bell Choir, and Brass Ensemble have all resumed rehearsals and are
 providing beautiful music for our worship services. Thank you to everyone who shares their musical talents
 for worship!
- Expanded music copyright licensing Our 'cranberry hymnal' is 16-years-old and new music is being written every day. Purchasing additional music copyright coverage allows us to learn new songs for worship. In 2022 we sang 18 new songs that are not in the hymnal.

Thank you to our Office Administrator for creating bulletins and keeping worship volunteers organized; and thanks to all who help out in some way such as ushers, readers, acolytes, Altar Guild, or Tech Team. We look forward to more meaningful worship in 2023!

Social Ministries 2022 Year in Review

Our church has experienced several changes in the last year with more to come this coming year in 2023. We need to welcome these changes with love and open arms. Pray for blessings and guidance.

Social Ministries has slowly moved out of the pandemic years into a new normal. These are the projects that we worked on this year.

March was **Food Share Month** and we helped guide the congregation to help fill the shelves of the Cannon Falls Food Shelf along with the community participation.

Lutheran World Relief is always one of the big undertakings we face. This year we sent out 26 beautiful quilts made by our quilters. Every year they are displayed in the sanctuary for all to enjoy. We also were able to put together 47 school kits and 20 personal health care kits. That's a lot of pens and pencils and toothbrushes and soap. Thanks to Gary Thomas and Royce Anderson for the delivery of these large boxes. The congregation comes through every time.

We recognized 12 **high school seniors** this past year. We gave them each a tie blanket, that was tied with love by the women of the church. Many hands make fast work. Thanks to the ladies that participated.

Gods Work Our Hands was shelved this year for lack of a coordinator. If there is a willing individual that would volunteer to take this on, it would be greatly appreciated. It is a wonderful service to the church and the community.

Our last project of the year is our **Christmas Project**. This year we served six (60 families with a total of 14 children. They were all very appreciative of the gift cards and toys. We were a little below last years giving, but it was still a blessed Christmas. It was a small window of time for giving too.

In closing, I want to give credit to those on our committee. The quilters: Chris Pofahl and Sarah Novotny. They are always looking for others interested in quilting. Contact either one for more information.

FOUNDATION CLARIFICATION REPORT

AS OF 12/31/2022

The Foundation Board members for 2022 were: Emily Spicer, President; Cathy Rehm, Vice President; Rick Hughes, Secretary; Karen Anderson, Treasurer; Nicole Holz; Barb Elias; Elvena Schmugge; and Council President Mike Miller.

The purpose of this report is to provide the congregation with an overview of how our Church Foundation was founded, the accomplishments that have been achieved, and what the future holds for the Foundation of First English Lutheran Church. All amounts shown in the following paragraphs are rounded-off figures, not exact amounts. The exact figures for 2022 are listed in the Foundation Annual Report.

The original gift was received in 1981 from the Rose Helmbrecht Estate, and the value of the gift (after deductions for initial lawyers' fees, etc.) was \$368,000. To administer the terms of the will, the Church Foundation was established and adopted at the Annual Meeting on January 24, 1982. A Foundation Board was formed to help oversee the investment of the monies from the estate. The will specified that the principal of the gift was to be used for building purposes only. The Foundation Board stipulated that the interest would be set aside to be used by the Foundation for any operating expenses and the following purposes:

- 1) **Continuing Education** for educational purposes within our congregation;
- 2) Benevolence for outreach ministry outside of our congregation;
- 3) **Principal** to put interest monies back into the principal of the Foundation to build the assets for future building purposes.

As of December 31, 2022, we have given approximately \$223,158.00 to Benevolence areas; \$152,449.00 to Continuing Education purposes; and \$68,485.00 has been put back into the Principal; for a grand total of \$444,092.00.

Our 1st Building Project, from 1982 - 1987, included repairs to windows, Sunday School partitions, purchase of the Larson property, parking lot, and the major remodeling of the Church in 1987. The following is a breakdown of monies received for these projects:

1) From principal of Foundation	\$270,000

Our 2nd Building Project, from 1999 to 2002, includes the current major addition and re-modeling to our present Church building, plus the purchase of the (2) lots for the new parking lot. The Foundation had designated \$168,320 of their total assets as of 12/31/00 to be used for this Building Project and the Foundation has given that entire amount towards the Building Project expenses. The following is a breakdown of the monies for this project:

Over the years, we received another large gift that has been added to the Foundation assets which was the Carl Ostrom Memorial Fund of approximately \$54,000.00. It was stipulated in the will that the interest earned on the principal of this gift was to be used for Youth activities only and cannot be used in the normal budget of the Foundation.
